Bruce attended the bi-annual Todd County Lakes Association meeting

- Lake inspection:
 - The security and treatment of inspectors
 - Law enforcement lacking personnel
 - Fishing tournaments leaders of the tournaments need to contact the inspector if over 25
 - Inspection rates are \$19./hour includes training and supplies
 - There are 3 zones, 85% are big lakes, Lake Beauty is Zone 2
 - Bruce suggested changing the hours of the inspectors at Lake Beauty from 8AM to 4PM as there are more people coming in the later hours of the day
- Cost share for shoreline restoration work needs to be submitted by Jan. 15
- Rapid Response
 - o If you see a zebra mussle, milfoil, etc., report it early
 - Rhonda suggested a picture board at the access so boaters can easily identify and know what to look for
 - o Mary will contact Deja to see if they have something available for us to use
- Any questions about the meeting Bruce will be able to answer
